The method of payment will be by cash.

5. To qualify for award of contract for every bid where tenderable amount exceeds of **Rs. 5.0 Million**, bidder shall submit the certificate issued by the **Register of Companies** under the paragraph 8, of Public Contract Act No.03 of 1987.
6. All bids shall be accompanied with a bid security as indicated in the table given below and Bid securities in the form of a Bank Guarantee, Bank Draft /Cash shall be in the standard form given in the bidding documents.
7. Procurement Committee shall reserves the right to accept or reject any bids received or annul the process at any time without assigning any reasons for the same and to restrict the list of contractors to any number deemed suitable.
8. Bids will be opened immediately after the deadline for submission of bids, in the presence of bidders and/or their authorized representatives who choose to attend in person of contractors to any number deemed suitable.
